The purpose of the hearing is to receive comments from all interested parties regarding the adoption of the 2009 State Plan pertaining to the Department of Energy's (DOE) ARRA Low Income Weatherization Assistance Program funding for the period of July 1, 2009 to June 30, 2010.

Persons wishing to comment upon the proposed action of the Nevada Housing Division may appear at the scheduled public hearing or may address their comments, data, views, or concerns, in written form, to the Nevada Housing Division, Attention: Craig Davis, Weatherization Manager, 1535 Old Hot Springs Road, Suite 50, Carson City, Nevada 89706. Written submissions must be received by the Housing Division on or before 5:00 p.m. May 6, 2009.

If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Housing Division may proceed immediately to act upon any written submissions.

Copies of this notice and the proposed plan will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of the proposed plan, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
